Request for 30-day Special Temporary Authority

By this application for Special Temporary Authority (“STA”), Moynk Properties, LLC (“Moynk”) seeks authority to add space station Vigoride-3¹ as an additional point of communication to its fixed earth station located in Kapolei, Hawaii (the “Kapolei Earth Station”; Call Sign E202006). Moynk seeks to use two Viasat 5.4m antennae to communicate with Vigoride-3.²
