Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests 30 days of Special Temporary Authority ("STA"),¹ commencing May 2, 2023, to use its Nuevo, California Ku-band earth station, Call Sign E060384, to provide in-orbit testing ("IOT") services to Intelsat 40e (S3066) at its final orbital location of 91.0° W.L. Intelsat 40e is scheduled to launch no earlier than April 7, 2023. Intelsat expects to begin two months of IOT on May 2, 2023.

The proposed IOT will be performed at the following frequency bands:

- 13750-14500 MHz (uplink); and
- 10700-11200 MHz (downlink).²

In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Grant of this STA request will allow Intelsat to help test Intelsat 40e and place it into service, which will provide continuity of service and additional Ku- and Ka-band capacity over the continental United States. Grant of this request will thereby promote the public interest.
