Scope of Grant:	Universal Space Network Inc. ("USN"), is granted a 180-day special temporary authority (STA), to operate its satellite earth station to provide launch and early orbit phase (LEOP) and telemetry, tracking, and command (TT&C) support for the Sentinel 3C satellite, operated by the European Space Agency (ESA).	
Service Area(s):	64° 48' 15.268" N, 147° 30' 0.771" W in North Pole, AK	
Frequencies:	Operations will be performed at the following center frequencies: 2075.6504 MHz with an emission bandwidth of 768 kHz (Earth-to-space) 2254.1 MHz with an emission bandwidth of 2.2 MHz (space-to-Earth)	
Operations under this grant must comport with the legal and technical specifications set forth by the applicant or petitioner and with Federal Communication Commission's rules not waived herein. This grant is also subject to the following conditions:		
1. STA operations must not exceed the operational power levels and parameters requested and coordinated. 2. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users. 3. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., USN must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station. 4. In the event of any harmful interference caused by operations under this grant of STA, USN must immediately cease operations upon notification of such interference. USN must immediately inform the Commission, in writing, of such an event. 5. Earth station transmissions in the 2025–2110 MHz band are subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at https://sbe.org/resources/frequency-coordination/ to find the appropriate coordinator. 6. The 24/7 point of contact in the United States, with authority and ability to cease all emissions, for this operation is Mike Davis at +1 (907) 490-3064. 7. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein. 8. Grant of this STA does not constitute approval of U.S. market access. 9. All operations under this grant of STA shall comply with all existing and future space station coordination agreements reached between ESA, France, and other administrations.		

10. This STA is granted with a waiver of Commission's Rules 47 CFR §§ 25.137 and 25.114 to provide LEOP and TT&C services, given that no commercial service will be provided to the United States.

This grant is issued pursuant to section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release. This STA is authorized pursuant to the Commission's rule 47 CFR § 25.120.
