| <p><b>Operations under this grant must comport with the legal and technical specifications set forth by the applicant or petitioner and with Federal Communication Commission's rules not waived herein. This grant is also subject to the following conditions:</b></p> <p>1. STA operations must not exceed the operational power levels and parameters requested and coordinated.</p> <p>2. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users.</p> <p>3. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Haras must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station.</p> <p>4. In the event of any harmful interference caused by operations under this grant of STA, Haras must immediately cease operations upon notification of such interference. Haras must immediately inform the Commission, in writing, of such an event.</p> <p>5. Earth station transmissions in the 2025–2110 MHz band are subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. cycle for the uplink centered at 2086.9 MHz to a maximum of 75 percent and shall cease uplink transmissions when the International Space Station (ISS, NORAD ID 25544) is within 7 degrees of the earth station antenna boresight.

9. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein.

10. STA operations since the expiration of the previous STA and the commencement of this STA were authorized as continuing operations under 47 CFR § 1.62.

This grant is issued pursuant to section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release. This STA is authorized pursuant to the Commission's rule 47 CFR § 25.120.
