| <div>1. STA operations must not exceed the operational power levels and parameters requested and coordinated.</div> <div>2. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users.</div> <div>3. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Intelsat must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station.</div> <div>4. In the event of any harmful interference caused by operations under this grant of STA, Intelsat must immediately cease operations upon notification of such interference. Intelsat must immediately inform the Commission, in writing, of such an event.</div> <div>5. Operation in the territory or airspace of any country other than the United States must be in compliance with the applicable laws, regulations, and licensing procedures of that country, as well as with the conditions of this authorization.</div> <div>6. Operations in 14.0–14.2 GHz must be limited to those outside radio line-of-sight of the Federal TDRRS sites specified in 47 CFR § 25.228(j)(1).</div> <div>7. Operations in 14.47–14.5 GHz must be limited to those outside radio line-of-sight of active Federal sites identified in 47 CFR § 2.106(c)(113) (footnote US113) of the U.S. Table of Frequency Allocations and 47 CFR § 25.228(j)(3).</div> <div>8. 9. Grant of this STA does not constitute approval of U.S. market access.

10. All operations under this grant of STA shall comply with all existing and future space station coordination agreements reached between France and other administrations.

11. This STA is granted with a waiver of Commission's Rules 47 CFR §§ 25.137 and 25.114 to operate up to 500 each of the Ball 9x9 and ThinKom 2Ku aeronautical terminals with the E50WA satellite while Intelsat's request for authority to operate, ICFS File No. SAT-LOA-20260130-00070, is pending.

12. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein.
