Request for 30-day Extension of Special Temporary Authority (“STA”)

Moynk Properties, LLC (“Moynk”) respectfully seeks 30 day extension of STA previously granted to add Vantor License Inc.’s (“Vantor”) WorldView 1-3 and all WorldView-Legion satellites (Call Sign S2129)¹ as additional satellite points of communication to its fixed earth station located in Prudhoe Bay, Alaska (the “Prudhoe Bay Earth Station”; Call Sign E230174).² Vantor has coordinated the Prudhoe Bay Earth Station with NASA as reflected in its most recent authorization for the WorldView and WorldView-Legion satellites.³

Grant of this STA serves the public interest because it will enable Moynk to continue to support Vantor in accordance with its mission objectives.

Consistent with Section 1.62 of the Federal Communications Commission’s rules,⁴ Moynk will continue communicating with the WorldView 1-3 and WorldView-Legion satellites pursuant to the terms and conditions of its expiring STA pending grant of the instant extension request.⁵
