Scope of Grant:	Intelsat License LLC ("Intelsat"), is granted an additional 30-day special temporary authority (STA) to operate its satellite earth station to provide telemetry, tracking, and command (TT&C) services for the HYLAS-2 satellite (licensed by the United Kingdom), on-station at 72.5° W.L. orbital location.	
Service Area(s):	34° 24' 22.0" N, 118° 53' 34.0" W in Fillmore, CA	
Frequencies:	Operations will be performed at the following center frequencies: 6723.75 MHz (Earth-to-space) 4198 MHz (space-to-Earth) 4199 MHz (space-to-Earth)	
Operations under this grant must comport with the legal and technical specifications set forth by the applicant or petitioner and with Federal Communication Commission's rules not waived herein. This grant is also subject to the following conditions: 1. STA operations must not exceed the operational power levels and parameters requested and coordinated. 2. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users. 3. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Intelsat must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station. 4. In the event of any harmful interference caused by operations under this grant of STA, Intelsat must immediately cease operations upon notification of such interference. Intelsat must immediately inform the Commission, in writing, of such an event. 5. The 24/7 point of contact in the United States, with authority and ability to cease all emissions, for this operation is the Intelsat Network Operations Center (NOC) at +1 (404) 381-2900. 6. Grant of this STA does not constitute approval of U.S. market access. 7. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein. 8. All operations under this grant of STA shall comply with all existing and future space station coordination agreements reached between the United Kingdom and other administrations. 9. This STA is granted with a waiver of Commission's Rules 47 CFR §§ 25.137 and 25.114 to provide TT&C, given that no commercial service will be provided to the United States. 10. STA operations since the expiration of the previous STA and the commencement of this STA were authorized as continuing operations under 47 CFR § 1.62.		
This grant is issued pursuant to section 0.261 of the Commission's rules on delegated authority, 47 CFR §		

0.261, and is effective upon release. This STA is authorized pursuant to the Commission's rule 47 CFR § 25.120.
