Scope of Grant:	Hubble Network Inc. ("Hubble"), is granted a 60-day special temporary authority (STA), to operate Part 15 compliant devices to communicate with the Hubble 1-3 (S3182) and the Hubble 4-7 (S3212) satellites.	
Service Area(s):	United States & Possessions (US&P) and territorial waters	
Frequencies:	Operations will be performed in the following frequency bands: 2482.710675–2483.424 MHz (Earth-to-space)	
Operations under this grant must comport with the legal and technical specifications set forth by the applicant or petitioner and with Federal Communication Commission's rules not waived herein. This grant is also subject to the following conditions:		
1. STA operations must not exceed the operational power levels and parameters requested and coordinated, and must comport with the technical specifications described in the underlying application, as amended, except as conditioned in this grant of STA. 2. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users. 3. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Hubble must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station. 4. In the event of any harmful interference caused by operations under this grant of STA, Hubble must immediately cease operations upon notification of such interference. Hubble must immediately inform the Commission, in writing, of such an event. 5. Waiver of the U. S. Table of Frequency Allocations, 47 C.F.R. §2.106 and 47 CFR § 2.102(a) to operate unlicensed RF devices in the 2482.710675 - 2483.424 MHz frequency band is GRANTED. 6. Waiver of 47 C.F.R. § 25.271(g) (Radiofrequency Exposure Assessment) is GRANTED given that the RF devices will ensure radiofrequency exposure safety through the Part 2 equipment authorization process. 7. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein.		

This grant is issued pursuant to section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release. This STA is authorized pursuant to the Commission's rule 47 CFR § 25.120.
