All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Viasat must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station.<br><br>4. In the event of any harmful interference caused by operations under this grant of STA, Viasat must immediately cease operations upon notification of such interference. Viasat must immediately inform the Commission, in writing, of such an event.<br><br>5. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein.<br><br>7.
