

Haras Development E181423

Request for 30-day Extension of Special Temporary Authority (“STA”)

Haras Development (“Haras”) respectfully seeks a 30-day extension of STA previously granted to Haras to add Capella Space Corp.’s space stations Acadia-1 and Acadia-2 (Call Sign S3162)¹ as additional points of communication to its fixed earth station located in Dublin, Ohio (the “Dublin Earth Station”; Call Sign E181423).²

Grant of this STA is in the public interest because it will enable Haras to support Capella Space in accordance with its mission objectives.

Consistent with Section 1.62 of the Federal Communications Commission’s rules,³ Haras will continue communicating with Acadia-1 and -2 pursuant to the terms and conditions of its expiring STA pending grant of the instant extension request.⁴
