Hagerstown, Maryland Earth Station E140121

Dear Ms. Dortch:

Intelsat License LLC (“Intelsat”) herein requests a grant of Special Temporary Authority (“STA”)¹ for 60 days, commencing August 1, 2019, to use its Hagerstown, Maryland Ku-band earth station (Call Sign E140121) to provide telemetry, tracking, and command (“TT&C”) services for Galaxy 11 (Call Sign S2253) at its permanent location of 93.1° W.L.² Intelsat has a pending license application for this antenna to add Galaxy 11 as a point of communication.³

The proposed TT&C operations will be performed using the following frequencies: 14000.5 MHz and 14498.5 MHz in the uplink; and 11701.0 MHz and 11702.0 MHz in the downlink. The proposed operations at 93.1° W.L. will be consistent with Intelsat’s coordination agreements for the location.

In further support of this request, Intelsat incorporates by reference the technical information found in its pending application.⁴ In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.
