Re: Request for Extension of Special Temporary Authority
Hagerstown, Maryland Earth Station KA258

Dear Ms. Dortch:

Intelsat License LLC (“Intelsat”) herein requests an additional 30 days of Special Temporary Authority (“STA”)¹ previously granted to Intelsat² to use its Hagerstown, Maryland Ku-band earth station (Call Sign KA258) to provide telemetry, tracking, and command (“TT&C”) services for HYLAS-1³ during the satellite’s drift to and on-station at 79.0° W.L. Intelsat will provide TT&C services for approximately five months.

HYLAS-1 TT&C operations are being performed in the following frequencies:

- 17302.048 MHz (H, LHCP), and 17305.051 MHz (H, RHCP) in the uplink; and
- 11701.008 MHz (V, LHCP) and 11702.808 MHz (V, RHCP) in the downlink.

The drift operations will continue to be coordinated with all operators of satellites that use the same frequency bands and are in the drift path.⁴ All operators of satellites in that path have been provided with an emergency phone number where the licensee can be reached in the event that harmful

interference occurs. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Grant of this STA extension request will allow Intelsat to help the operator of HYLAS-1 safely drift and station-keep the satellite. This, in turn, will help ensure safe space operations and thereby promotes the public interest.
