Re: Request for Further Extension of Special Temporary Authority to Operate a 13.1-meter C-band Antenna at Intelsat's Hagerstown, Maryland Teleport

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests an additional 30 days of Special Temporary Authority ("STA")¹ previously granted to Intelsat² to utilize a 13.1-meter C-band antenna located at its Hagerstown, Maryland teleport for antenna verification testing. Due to staffing constraints, Intelsat expects the testing to take at least an additional 30 days.

The communication services will continue to be performed in the 5850-6725 MHz (uplink) and 3400-4200 MHz (downlink) bands. Based on availability, Intelsat will be communicating with various Intelsat satellites for the testing.³

In further support of this request, Intelsat incorporates by reference Exhibits A and B of its original STA request,⁴ which contain technical information that demonstrates that the operation of the earth station will be compatible with its electromagnetic environment and will not cause harmful interference into any lawfully operating terrestrial facility, as well as a radiation hazard analysis

report. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Grant of this further STA extension request will help ensure this antenna is operational prior to its use during a power upgrade at Intelsat's Hagerstown, Maryland teleport later this year, which in turn will ensure customer service during the upgrade. As such this request is in the public interest.
