Domestic fixed earth stations E860670 and E860687 are used in connection with the operation of television broadcast station KOVR(TV), Sacramento, California. On May 30, 2003, an application was filed requesting Commission consent to the pro forma inter-company transfer of control of SCI-Sacramento Licensee, LLC from Sinclair Communications, Inc. to Sinclair Communications, LLC. See FCC File No. BTCCT-20030530DVP. Thus, a similar transfer of E860670 and E860687 will permit continued joint operation of the earth stations and television facilities in the provision of television broadcast services.
