On May 30, an application was filed requesting Commission consent to the voluntary pro forma inter-company transfer of control of WSYX Licensee, Inc. from Sinclair Communications Inc. to Sinclair Communications, LLC. See FCC File No. BTCCT-20030530DVU. A similar transfer of E860987 and E3843 will permit continued joint operation of the earth stations and television facilities by the same licensee in the provision of television broadcast services.
