On August 13, 2003, an application was filed requesting Commission consent to the voluntary pro forma inter-company transfer of control of WSYX Licensee, Inc. from Sinclair Communications, LLC to Sinclair Television Group, Inc. See FCC File No. BTCCT-20030813ACP. A similar transfer of E930283 will permit continued joint operation of the earth station and television facilities by the same licensee in the provision of television broadcast services.
