Rc: Minor Amendment to Application for FCC Consent to Transfer of Control of OrbView-3 Earth Station Licenses

Dear Ms. Dortch:

On September 24, 2003, Orbital Imaging Corporation ("ORBIMAGE" or the "Company") filed an application (the "Application") with the Federal Communications Commission (the "FCC") for consent to the assignment and transfer of control of ORBIMAGE's OrbView-3 earth station licenses, file number SES-T/C-20030924-01416, from Orbital Imaging Corporation, debtor-in-possession to reorganized ORBIMAGE, Inc. ("Reorganized ORBIMAGE").¹


Except as discussed above, to the best of ORBIMAGE's knowledge, all other information previously provided to the Commission in connection with the Application remains unchanged as of the date hereof.
