Indirect Ownership in Filer

American Messaging Services, Inc. (the "Filer") is majority owned and controlled by American Messaging Services, L.P. ("AMSL"). The following individuals or entities hold either controlling interests, or equity interests of 10% or more, in AMSL: Colchester Capital, LLC; Incyte Capital Partners, LLC, George S. Rich; Granite Point Capital, L.P.; GRI Fund, L.P.; and Valley Forge Fund, IV, L.P. The two controlling general partners of AMSL – Colchester Capital, LLC and Incyte Capital Partners, LLC – are wholly-owned and controlled, respectively, by Thomas J. Hopkins and Marc A. Gineris.
