Dear Mr. Nelson:

By action dated October 17, 2006, the International Bureau, pursuant to delegated authority, granted the above-referenced application for transfer of control of KCCP Trust, licensee of Temporary Fixed Earth Stations E020130 and E040257, Kansas City, Missouri. Under Section 25.119(f) of the Commission's Rules, the transfer of control must be completed within 60 days of October 17, i.e. by December 16, 2006. On behalf of KCCP Trust, we are hereby requesting a thirty (30) day extension of the completion date.

The transfer of control of KCCP Trust is a component of a large transaction that involves the transfer of numerous cable systems and assignments of their licenses in the Business Radio, Cable Television Relay Station, Fixed Satellite and Fixed Microwave services (all of which have been approved by the Commission). The parties require additional time to obtain local approvals necessary for the transfer of certain of the cable systems involved in the transaction. It is expected that such approvals will be obtained by December 31, and that the closing will occur as of January 1, 2007. To provide additional time in the event the closing schedule is not met, we are requesting a thirty (30) days extension of the transfer of control completion deadline, from December 16, 2006 to January 15, 2007.
