This application requests consent for the transfer of control of PetroCom License Corporation ('PetroCom') from the current shareholders of its parent company, S&P Cellular Holding Company, LLC ('S&P Cellular') to Trident Global Communications LLC ('Trident'). PetroCom holds a number of Domestic Fixed Satellite transmit/receive earth station licenses and Very Small Aperture Terminal ('VSAT') licenses. Trident has entered an agreement with the current shareholders of S&P Cellular whereby all of the issued and outstanding stock of S&P Cellular will be transferred to Trident, to be effective following the grant of FCC consent to the transfer of control.
