INDIRECT OWNERSHIP INTERESTS

Filer, Critical Alert Systems, LLC, is a limited liability company whose membership shares are 100.0% owned directly by Critical Alert Holdings, LLC (“Holdings”), a Delaware limited liability company.

Holdings is 69.65% owned by CAS Investment Corp, a Delaware corporation, with the remaining 30.35% held by various individual investors, only one of whom – Bruce R. Lederman – owns 10.00% of more of the filer’s membership shares.¹

CAS Investment Corp. is wholly owned by Wedbush Capital Partners, LP (“WC-LP”), a Delaware Limited Partnership,

The sole general partner of WC-LP, Wedbush Capital GP LLC (“WC-GP”), a Delaware limited liability company, is the ultimate controlling entity of Filer by virtue of having management control of WC-LP as well as the exclusive right to appoint three of the five members of the governing board of Filer. There are four members of WC-GP. They include Peter V. Shoemaker, Eric D. Wedbush, Geoffrey C. Bland, and Wedbush, Inc., a California corporation. The management and control of WC-GP, and thus ultimately of Filer, is vested in a three-member Management Committee consisting of Messrs. Shoemaker, Wedbush and Bland. Wedbush, Inc. owns 100% of the equity of WC-GP, but does not have voting control of or manage that entity or Filer. No single shareholder of Wedbush, Inc. owns 10% percent or more of the stock of Wedbush, Inc.

The limited partners of WC-LP include the members of WC-GP (i.e., Messrs. Wedbush, Bland, and Shoemaker and Wedbush, Inc.). Wedbush, Inc. holds a 16.67% limited partnership interest in WC-LP. Additionally, Caledonia Investments PLC, a UK company, holds a 16.67% limited partnership interest in WC-LP. No other individuals or entities hold a 10% or greater interest in WC-LP.

The three members of the governing board of Filer appointed by the Wedbush interests are Messrs. Shoemaker and Bland, together with another Wedbush business associate Kevin Tom. The remaining two members of the governing board of Filer are Bruce D. Lederman and Edward B. Meyercord, who is the Chief Executive Officer of Filer. The same individuals who serve on the governing Board of Filer are also the Managers of Holdings.

¹ Mr. Lederman holds a total 10.93% indirect interest in Filer through two Trusts of which he is the Trustee. The Lederman Family Trust holds a 10.20% indirect interest in Filer, and the Lederman’s Children’s Trust holds a 0.73% indirect interest.
