Gogo Inc. (Gogo) seeks consent for a transfer of de facto control of Gogo LLC blanket authorization to operate a Ku-band aeronautical mobile-satellite earth station network that will occur in conjunction with a planned initial public offering (IPO) of Gogo shares. Although no entity holds 50 percent or more of Gogos shares, de facto control is currently held by Ripplewood Partners II, L.P. (Ripplewood) through a Stockholders Agreement. Upon completion of the IPO, that agreement will be terminated, and neither Ripplewood nor any other single entity or individual will have de facto or de jure control of Gogo.
