The applicant seeks Commission consent to the pro forma transfer of control of the below referenced earth station nunc pro tunc from Sinclair Television of Nashville, Inc. ('STNI') to Sinclair Communications, LLC. As the Commission is aware, the licensee is ultimately owned by Sinclair Broadcast Group, Inc. More specifically, the licensee's sole member is STNI, which in turn was wholly-owned by Sinclair Communications, LLC ('SCLLC'). SCLLC is wholly-owned by Sinclair Television Group, Inc., which in turn is wholly-owned by Sinclair Broadcast Group, Inc. The instant transaction was undertaken as part of an internal reorganization and merger which resulted in no substantial change in ownership. The internal reorganization was previously reviewed and approved by the Media Bureau. See FCC File No. BTCCDT-20131211BET.
