

Changes in Interests

This exhibit provides information pertaining to the proposed transfer of control of Dignity 3E License (“Dignity License”) from Alpha Media Holdings LLC (“Alpha Holdings”) to Alpha Media USA LLC (“Alpha USA”). Alpha Holdings proposes to effect this transfer of control simultaneously with consummation of the transaction through which it will acquire 112 AM and FM and associated FM translator station licenses controlled by Dignity, LLC (“Dignity”) BTC(H)(FT)-20150811ADU-AFT, including the transfer of control of the licenses currently held by Dignity 3E License, LLC (“Dignity License”), which are the subject of this application. As part of a corporate restructuring, upon closing of the Dignity transaction, Alpha USA will be a new LLC wholly owned by Alpha Holdings, and Alpha USA, in turn, will wholly own Alpha 3E Corporation, the indirect parent of Dignity License and the direct parent of Dignity 3E Corporation which will be, in turn, the direct parent of Three Eagles Communications, Inc. (see organizational chart demonstrating structure before and after, attached). The attributable interests in each of these entities are listed in the tables that follow. No contracts or agreements are associated with this transaction. Alpha Holding’s qualifications were passed upon by the Commission in connection with the aforementioned Dignity transaction – consent to the underlying transfer was granted on October 9, 2015.

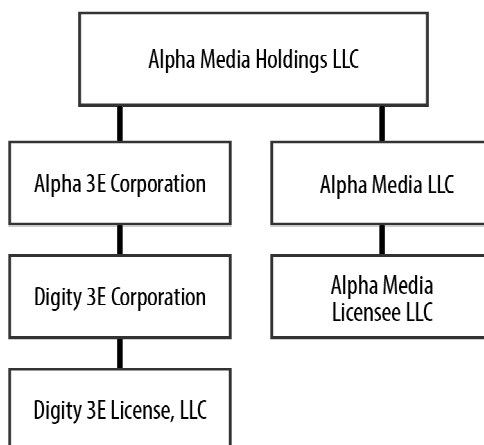
