The application for pro forma transfer control of the Infosat earth station has been granted. The filing for the Section 214 authorizations was only a notification, because the transfer of control was pro forma, but IBFS is showing that filing as having been "granted," too.

On the first go round, you had to handle the consummation from your side because IBFS will not accept a consummation notice for a date that precedes the filing of the application. Can you do the same thing for the more recent filings? I am not certain whether consummation is necessary for the Section 214 notifications. The file numbers are ITC-T/C-20170519-00099 and SES-T/C-20170519-00572.

Infosat holds an earth station license, two international Section 214 authorizations, and non-common carrier wireless licenses.
