#### Dear Secretary Dortch:

On behalf of Clarity Telecom, LLC d/b/a Vast Broadband ("Clarity" or "Registrant"), PC III CTH Holdings, L.P. ("PC III Holdings" or "Transferor") and Python Intermediate II, LLC ("Python" or "Transferee"), (together, the "Parties"), this letter notifies the Commission of the transfer of indirect control of Clarity from Transferor to Transferee (the "Python Transaction").

Pursuant to Section 25.119(j) of the Commission's rules, approval was not required for the Python Transaction. This letter is intended to constitute a notice of the Python Transaction with

respect to (1) the receive-only earth station registrations pending in the above-referenced proceedings and (2) Registrant's receive only earth station registrations associated with the above-referenced Call Signs.

#### **Description of the Parties**

#### A. Clarity Telecom, LLC (Registrant)

Clarity is a telecommunications provider headquartered in Sikeston, Missouri and provides telecommunications services in Minnesota and South Dakota doing business under the brand Vast Broadband. Clarity provides an array of communications, video and broadband services, including digital cable, high speed Internet, and local and long distance phone services. The direct parent company of Clarity is Clarity Telecom Holdings, LLC ("Clarity Holdings"), a Delaware limited liability company. Prior to the Python Transaction, Clarity Holdings was majority owned by investment funds managed by Pamlico Capital, including Transferor.

#### B. PC III CTH Holdings, L.P. (Transferor)

PC III Holdings was formed for the purpose of investments in Clarity Holdings. PC III Holdings is majority owned and controlled by funds and entities affiliated with Pamlico Capital.

#### C. Python Intermediate II, LLC (Transferee)

Python, a Delaware limited liability company, is a newly formed company created for the purpose of acquiring Clarity Holdings. Python is indirectly, wholly owned by Python Holdings, L.P. ("Python Holdings"), an investment fund also created for the purpose of the Python Transaction. Python Holdings is primarily owned and controlled by funds and entities affiliated with Pamlico Capital and Oak Hill Capital Partners, which are private equity funds based in the United States.<sup>2</sup>

#### **Description of the Transactions**

Pursuant to an Agreement and Plan of Merger dated as of December 24, 2018, a series of mergers and other transactions completed on August 30, 2019 resulted in Transferee directly or indirectly owning all of the issued and outstanding equity interests of Clarity Holdings (the "Python Transaction"). Upon completion of the Python Transaction, Clarity Holdings became a wholly owned subsidiary of Transferee. Clarity remains a wholly owned subsidiary of Clarity Holdings and became an indirect, wholly owned subsidiary of Transferee.


