AMENDMENT

Pursuant to Section 1.65(a) of the Commission's rules, Searchlight III UTD, L.P. ("Searchlight") hereby updates the pending applications for the transfer of control (the "Applications") of Univision Holdings, Inc. ("Univision") in MB Docket No. 20-123 to add four additional attributable interest holders in Searchlight Capital Partners III GP, L.P. ("Searchlight III GP") who acquired their limited partnership interests subsequent to the filing of the Applications.¹

As detailed in the Applications, Searchlight III GP is the sole member of Searchlight III UTD GP, LLC, which, in turn, is the sole general partner of Searchlight.² Subsequent to the filing of the Applications, Searchlight III GP admitted four additional limited partners. Although these new limited partners will each hold less than a 1% indirect equity interest in Univision, they are not fully insulated in accordance with the standards set forth in Section 73.3555 of the Commission's rules and, accordingly, are deemed to hold an attributable interest in Univision. Accordingly, Searchlight hereby amends the chart on pages 16-18 of the April 27 Amended Comprehensive Exhibit to add the following individuals:
