The Commission is notified that the applicants for the above-referenced application (“Application”) have provided complete responses to initial questions posed by the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (“Committee”).¹ The Committee is conducting an initial review to assess whether granting the Application will pose a risk to the national security or law enforcement interests of the United States.

The Committee shall complete its initial review of the Application before the end of the 120-day initial review period, which begins on the date of this letter. The Commission will be notified promptly in the event of an extension of the 120-day initial review period or the need arises to conduct a 90-day secondary assessment.
