Each of the Brian A. McBride FMBC Irrevocable Trust of 2020, the Maureen McBride FMBC Irrevocable Trust of 2020 and the Kathleen M. Plum FMBC Irrevocable Trust of 2020 contains the following limitation on the actions of all persons acting under the terms of the trust:

Federal Communications Commission Provisions

<u>Section 1</u> – <u>Federal Communications Law to Govern Administration</u>. All persons and entities acting under this instrument and each trust administered under this instrument must comply with the statutes, rules and policies administered by the FCC. Accordingly:

- (a) FCC Law will take precedence over any contrary right of obligation expressed in this instrument.
- (b) Every power granted, every right granted and every obligation or discretionary act undertaken under this instrument, or if silent, applicable trust law, are granted or to be undertaken to the full extent permitted by FCC Law, but only to the extent permitted by FCC Law.
- (c) By way of illustration of <u>Section 1(b)</u> but not limitation:
 - (1) No security interest may attach to an FCC license unless and until FCC Law permits creation of such a security interest.
 - (2) No transfer of control or assignment of a broadcast license may occur without prior application to and approval by the FCC.
 - (3) No attributable interest in a broadcast licensee may be acquired by any person lacking he character qualifications to be an FCC licensee.
 - (4) No foreign national or company organized under the laws of a foreign state may acquire a direct or indirect ownership interest in a broadcast licensee exceeding the limits established by FCC Law.
 - (5) No person may acquire an attributable interest in a broadcast licensee if that interest, in combination with other attributable media interests held by that person or by other attributable owners of the broadcast licensee, exceeds the permissible ownership limits prescribed in FCC Law.

 - (5) All of Section 2(b)(1), Section 2(b)(2), Section 2(b)(3) and Section 2(b)(4) as they presently exist and as they may be amended, supplemented, changes and/or superseded (by legislation, rulemaking, adjudication or otherwise) in the future.

The proposed transfers described above are to be made for estate planning purposes. No agreements exist obligating the transferors to transfer FMBC stock to the transferees.
