Response to Question A21 Exhibit F – Public Interest Statement

This application seeks Commission consent to the *pro forma* transfer of control of GATR Technologies, Inc. ("GATR"), licensee of two non-common-carrier transmit-receive earth station licenses. GATR holds a license for a Temporary Fixed Earth Station in the Fixed Satellite Service (Call Sign E090054) and a license for a VSAT network (Call Sign E080108). The *pro forma* transfer reflects the final disposition of these assets following acquisition of GATR's corporate parent, Cubic Corporation ("Cubic"), by Atlas CC Acquisition Corp. ("Atlas.").¹

The sole reason for the instant application concerns the conversion of the following two entities in the vertical ownership chain of Atlas from private corporations to limited liability companies: Atlas CC Holding LLC and Atlas Intermediate Holding LLC (the "Intermediate Atlas Entities"). Attachment 1 to Exhibit E illustrates GATR's ownership structure with the Atlas Intermediate Entities as private corporations, and Attachment 2 to Exhibit E illustrates that same structure, but with the Atlas Intermediate Entities as LLCs and with minor, non-substantive ownership percentage updates. Contemporaneous with this application, Atlas is filing applications for the *pro forma* transfer of control of Cubic's wireless and experimental licenses with the Commission's Wireless Telecommunications Bureau and with the Office of Engineering and Technology, respectively.

The above-described conversions have no impact on the ultimate control or ownership of GATR or any of the other licensee subsidiaries involved in Atlas' acquisition of Cubic. The conversions covered by this application serve the public interest by creating operational and administrative efficiencies for GATR and the other Cubic licensees.

Request for Waiver. On May 25, 2021, Atlas and Cubic consummated a substantial change in control involving the acquisition of Cubic, including GATR and its subsidiaries, by Atlas.² The Commission consented to this transaction pursuant to a series of approvals granted in March and April 2021. However, due to an inadvertent oversight, the Intermediate Atlas Entities were reported in the underlying applications for that transaction as private corporations, rather than as LLCs as they existed at the time of consummation on May 25, 2021. Atlas accordingly and respectfully requests acceptance and grant of this *pro forma* transfer application *nunc pro tunc* relating back to that date, which the Commission may grant pursuant to Section 1.3 of its rules.³ Good cause exists for the waiver of the requirement that prior approval of the *pro forma* transfer (*i.e.*, the LLC conversion) be received prior to consummation thereof. Failure to reflect the correct form of the Intermediate Atlas Entities in the prior applications was an
