Re: Notification Regarding the *Pro Forma* Transfer of Control of the Receive Only Earth Station Registrations of Lumos Media, LLC (Call Sign E060217) and North State Communications, LLC (Call Sign E080236)

Dear Secretary Dortch:

MTN Infrastructure TopCo, LP ("MTN Infrastructure"), Lumos Media, LLC ("Lumos Media") and North State Communications, LLC ("North State Communications") (Lumos Media and North State Communications, collectively the "Registrants" and, together with the Transferor and Transferee, the "Parties"), hereby notify the Commission of a *pro forma* change in the intermediate ownership of the Registrants, that resulted in the Registrants becoming an indirect subsidiary of Gridiron Fiber Corp. (the "*Pro Forma Separation*"), which is itself a subsidiary of the Registrants current parent, MTN Infrastructure.

As part of the *Pro Forma Separation* Lumos Media, LLC converted from a Virginia corporation to a Virginia limited liability company.

This Notice is part of a series of transactions that were completed on October 4, 2021 and resulted in changes to the ownership and control of MTN Infrastructure and its subsidiaries, including Lumos Media and North State Communications (the "Transaction").<sup>1</sup>

Pursuant to Section 25.119(j) of the Commission's rules, approval was not required for the Transaction. Accordingly, this letter is intended to constitute a notice of the Transaction with respect to Registrant's receive-only earth station registrations associated with the above-referenced Call Signs.

### **Description of the Parties**

#### A. MTN Infrastructure TopCo, LP

MTN Infrastructure is a Delaware limited partnership. MTN Infrastructure does not hold any authorizations from the FCC.

#### **B. Lumos Media, LLC**

Registrant Lumos Media is a Virginia limited liability company and is an indirect, wholly owned subsidiary of MTN Infrastructure. Lumos Media LLC holds Commission authorization for a receive-only earth station, (Call Sign E060217 in File No. SES-REG-20060609-00961; SES-RWL-20210430-00754).

## C. North State Communications, LLC

Registrant North State Communications is a North Carolina limited liability company and is an indirect, wholly owned subsidiary of MTN Infrastructure that operates as a provider of non-dominant telecommunications services in North Carolina. In addition to its receive-only earth station registration (Call Sign E080236 in File No. SES-REG-20081119-01500), Registrant is also authorized by the FCC to provide domestic (interstate) telecommunications services.
