

Description of Transaction

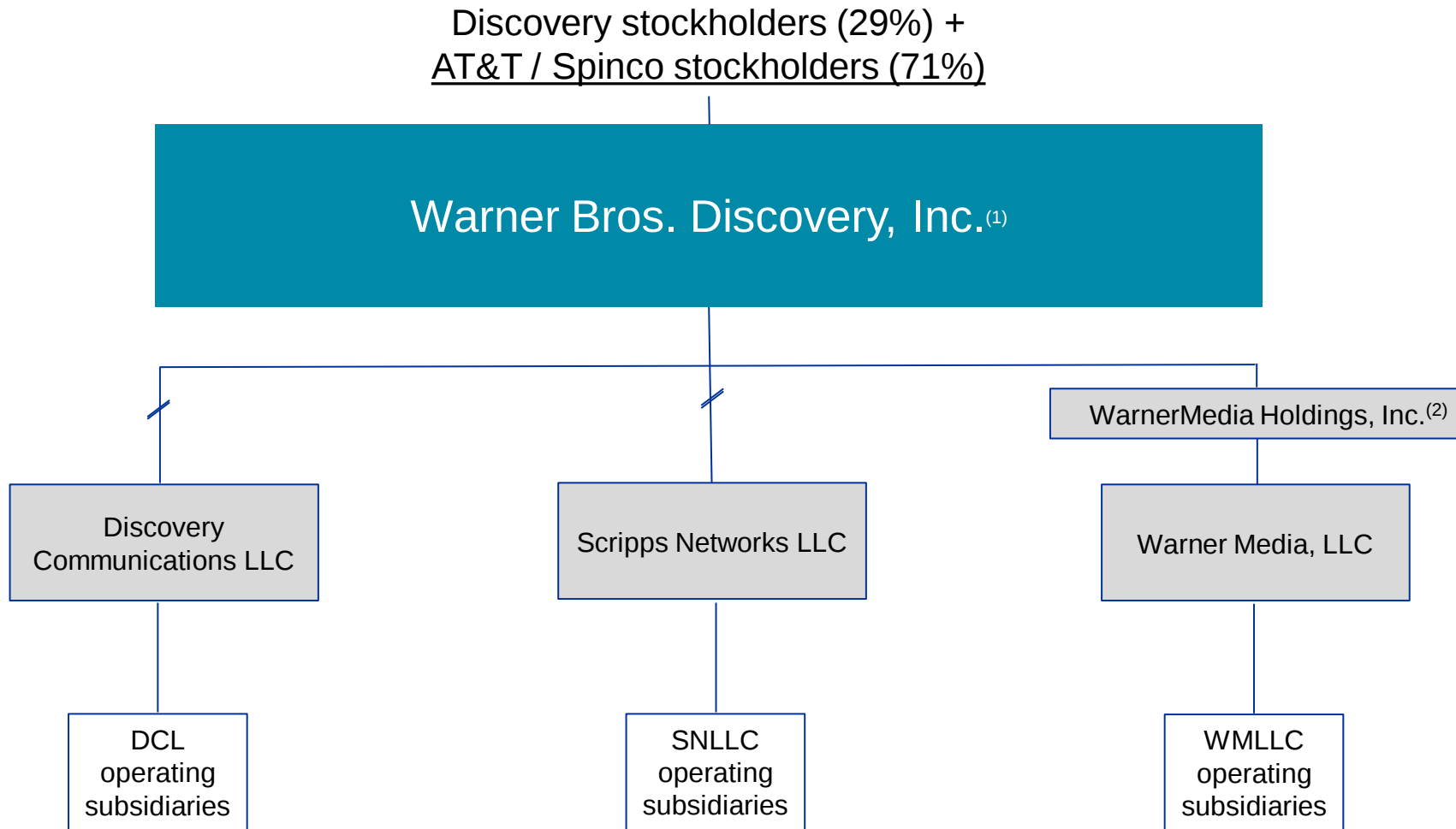
This notification of transfer of control of receive-only registrations is part of the transaction between AT&T Inc. (“AT&T”) and Discovery, Inc. (“Discovery”). The Parties closed the transaction on April 8, 2022. Pursuant to the transaction, Discovery acquired the business, operations, assets and liabilities constituting the WarnerMedia segment of AT&T. The transaction combined WarnerMedia’s assets and liabilities with Discovery’s existing media businesses to create an expanded global entertainment company which has been renamed Warner Bros. Discovery, Inc. (“Warner Bros. Discovery”).
