Request for the Commission's consent to the involuntary transfer of control of earth station license KA365 from PT Cable, Inc. ('PT Cable') to Terrence J. Donahue, the Chapter 7 Trustee for the bankruptcy estate of PT Cable. An involuntary petition in bankruptcy was filed against PT Cable on January 5, 2005 and PT Cable has consented to this filing. An Order for Relief was entered by the Bankruptcy Court for the Western District of Washington on March 22, 2005. On April 5, 2005, the Bankruptcy Court appointed Terrence J. Donahue as trustee of PT Cable's estate. Mr. Donahue currently exercises control over Neptune Pacific License Corporation and earth station KA365. See also Exhibit B.
