

Exhibits E and F for Transfer of Control Application

This application seeks the Commission's authorization to transfer control of earth station licensee SkyBitz, Inc. and its non-common carrier earth station license E00725 from Avista Capital Partners to EMA Corp., a U.S. corporation. This license provides SkyBitz authority to operate up to 450,000 mobile earth terminals in portions of the L-band (specifically, 1626.5-1660.5 MHz, 1574.42-1576.42 MHz, and 1525.0-1559.0 MHz) on Inmarsat and MSAT satellites.

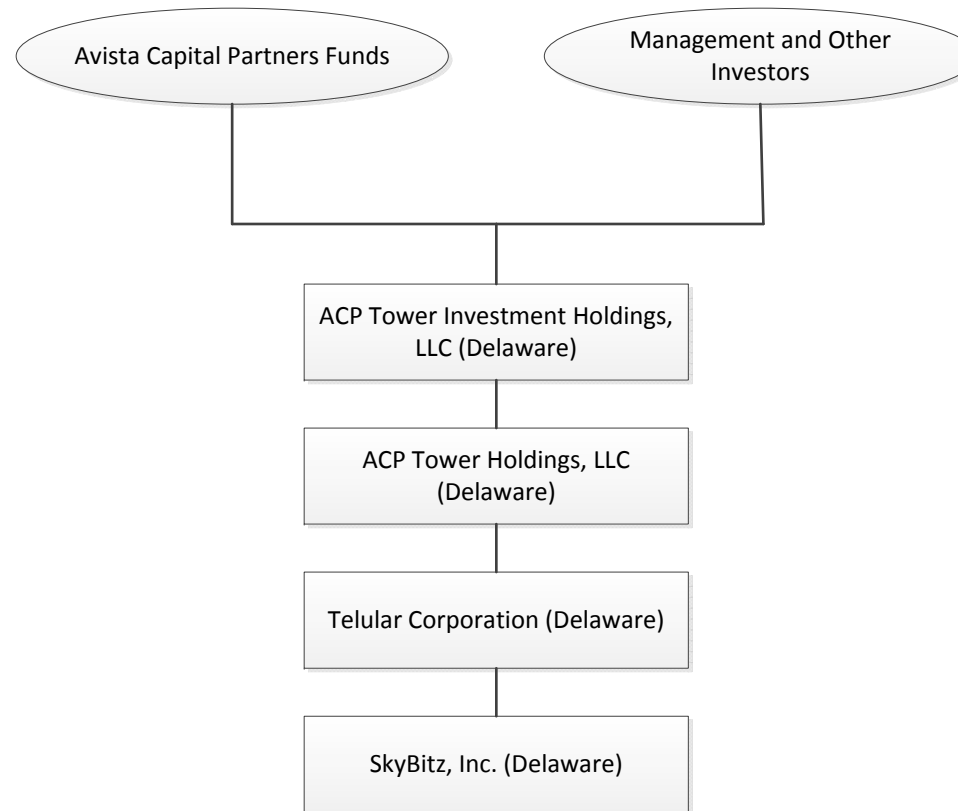

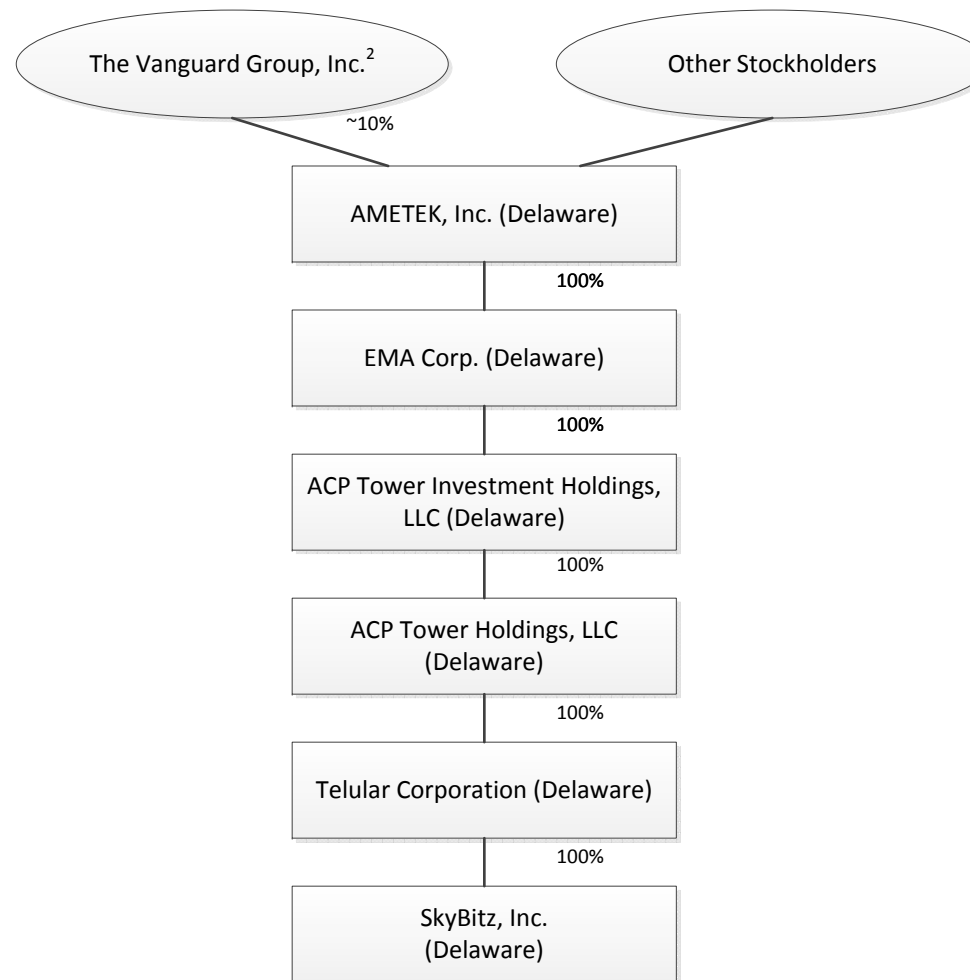
