#### I. Introduction and Summary

This application is one of three concurrently filed applications that seek Federal Communications Commission ("FCC" or "Commission") consent for a transaction (the "Transaction") to be effectuated pursuant to the terms of a Stock Purchase Agreement dated as of June 26, 2019 (the "Purchase Agreement"), among Terrier Media Buyer, Inc. ("Terrier Media"),<sup>1</sup> a Delaware corporation; Terrier Media Holdings, Inc., a Delaware corporation ("Terrier Holdings"); Cox Enterprises, Inc., a Delaware Corporation ("Cox Parent"); Cox Media Group, LLC, a Delaware limited liability company; Cox Media Group Ohio, Inc., a Delaware corporation; and Cox Radio, Inc. ("Cox Radio"), a Delaware corporation (collectively, "Cox"). As described in more detail below, under the terms of the Purchase Agreement, Terrier Media will acquire Cox Radio, Inc.'s remaining radio broadcast business, which includes full-power FM and AM radio stations (and associated earth station, microwave, and land mobile facilities)<sup>2</sup> Cox's national advertising representation business, and Cox's Washington, D.C. news bureau operations.<sup>3</sup>

The Transaction complies with the Commission's rules, and presents no potential concerns about competition, localism, and diversity. Due to the Commission's current local radio ownership rule,<sup>4</sup> Terrier Media cannot acquire all of Cox Radio's stations in the Orlando and Tampa Nielsen Audio markets. In Section VII below, Terrier Media provides an analysis of the Transaction's compliance with the Commission's local radio ownership rule in each of the other Cox Radio markets. For the Orlando and Tampa markets, Cox Radio is simultaneously seeking consent to assign one license in each market to a divestiture trustee, who will be charged with selling the stations to a third party or parties, to the extent such stations have not been sold as of the closing of the Transaction.

Thus, this application is one of three applications being filed concurrently:

- One application seeking consent to the transfer of control of Cox Radio's stations identified on Attachment 1 hereto (the "Cox Radio Stations").
- One application seeking consent to the assignment of one radio station in the Tampa market and one application seeking consent to the assignment of one radio station in the Orlando market, in each case to the divestiture trustee.

Terrier Media, as a new entrant in the broadcast radio market, will foster competition in the local markets and provide additional resources to improve service to the local communities without harming competition, diversity of voices, or content in any local radio market. As described in Section III below, the Transaction strongly serves the public interest, and the Applicants urge the Commission to promptly process and grant the associated applications.

# II. Description of the Transaction

The Transaction is an acquisition by Terrier Media of Cox Radio, Cox's national advertising representation business, and Cox's Washington, D.C. news bureau operations. In the Transaction, Terrier Media will acquire Cox Radio's remaining 50 full-power FM and AM radio stations and the associated earth station, microwave, and land mobile facilities. The Transaction, as described below, complies fully with Commission rules and precedent.

## A. Ownership at Closing of the Transactions

Attachment 2 hereto depicts the post-consummation ownership structure of the transferee Terrier Media assuming the prior consummation of the Cox TV Transaction and the Northwest Transaction.<sup>5</sup>

AP IX Titan Holdings, L.P., a Delaware limited partnership ("Titan"), expects to hold approximately 77% of the stock of Terrier Holdings and thus will control Terrier Holdings, which, in turn, will control Terrier Media Holdings II, Inc., which will control Terrier Media. The majority of the remaining interest of Terrier Holdings will be held by Cox Parent, with the remainder held by Brady, Wolff, and Bristlecone upon the closing of the Northwest Transaction and Cox TV Transaction.<sup>6</sup>

The general partner of Titan – AP IX Titan Holdings GP, LLC – is a Delaware limited liability company, the sole member of which is AP IX (PMC) VoteCo, LLC ("VoteCo"). VoteCo has three members: Scott Kleinman, John Suydam, and David Sambur, each of whom will vote a one-third interest in VoteCo. Apart from interests anticipated as a result of the Cox TV Transaction and the Northwest Transaction as described above and reported in this Exhibit, none of the three members of VoteCo has other reportable media interests and each of them is a natural person and a citizen of the United States. A majority of the members of VoteCo may admit additional members by written consent and any member may be removed upon the vote of the other members. Any member may resign from VoteCo at any time. VoteCo is wholly owned and controlled by its three members. Officers of VoteCo are appointed by the members and hold office until (i) their successors have been duly appointed and qualified or (ii) their earlier death, resignation or removal from office by vote of a majority of the members.

The sole limited partner of Titan will be AIF IX (PMC Equity AIV), L.P. ("PMC Equity"), a newly formed Delaware limited partnership whose sole general partner will be VoteCo, an entity that, as described above, is wholly owned and controlled by natural persons who are citizens of the United States. Each of the limited partners of PMC Equity will be "insulated" from material involvement in the business and operations of Titan, including the broadcast operations and activities of Terrier Holdings and its subsidiaries, in accordance with Commission policy.

The insulated limited partners of PMC Equity will consist overwhelmingly of entities controlled and owned, directly or indirectly, by citizens of the United States, including private pension funds, insurance companies, endowments, charitable foundations, private companies and high net worth individuals. PMC Equity is anticipated to have 64 limited partner investors, with the largest investor holding slightly less than 10 percent and with only four other investors holding more than five percent of the ownership of PMC Equity, each of whom is a large public pension fund. Over ninety percent of the limited partners of PMC Equity will be entities organized under United States law. Foreign ownership in PMC Equity, arising principally from minority foreign interests in certain of PMC Equity's limited partners, will be well below the 25 percent benchmark in Section 310(b)(4) of the Communications Act and is not anticipated to exceed 10% in the aggregate.

As part of the financing structure, Titan will issue transferable warrants for limited partnership interests. As a matter of policy, the Commission does not treat warrants as attributable for purposes of the Commission's ownership rules and does not consider warrants in assessing compliance with foreign ownership ceilings unless and until the warrants are exercised. The warrants will include provisions preventing the exercise of the warrant or the issuance of equity in response to a warrant holder's conversion request unless Titan determines that the issuance of the interests to the warrant holder following conversion would not cause any non-conformity with FCC ownership rules or with the restrictions on foreign ownership in the Communications Act and FCC rules and policies.

#### **B.** Foreign Ownership Compliance

As explained above, three natural persons who are United States citizens will indirectly vote approximately 77% of the stock of the licensee parent company Terrier Holdings, which,

accordingly, complies with Section 310(b)(4) as to foreign voting rights. Minority shareholders of Terrier Holdings contribute in the aggregate approximately one percentage point of non-U.S. voting rights to the foreign voting rights in Terrier Holdings. Thus, Terrier Holdings complies with Section 310(b)(4) as to foreign voting rights and each of its subsidiaries, being wholly controlled by Terrier Holdings, likewise complies.

Limited partner investors in the ownership chain of Terrier Holdings are all insulated in accordance with the FCC's rules and direct and indirect foreign ownership from limited partner investors is not expected to exceed 10%, with minority shareholders of Terrier Holdings contributing in the aggregate approximately one percentage point of non-U.S. ownership. Accordingly, Terrier Holdings complies with Section 310(b)(4) as to foreign ownership and each of its subsidiaries, being wholly owned by Terrier Holdings, likewise complies.

Terrier Media expects to have a business relationship with certain subsidiaries of Apollo Global Management, LLC ("AGM") upon consummation of the pending transactions. Certain subsidiaries of AGM will play an advisory role with respect to certain aspects of the proposed transactions and operations of Terrier Media. Terrier Media is not aware of any precedent under the Commission's foreign ownership rules that would treat Terrier Media's proposed contractual relationship with AGM as creating a cognizable interest. However, Terrier Media recognizes that the Commission's review and analysis of interests and relationships under the foreign ownership rules differs from its review and analysis under the media ownership rules. AGM is a Delaware limited liability company controlled by three U.S. citizens, but AGM is treated as foreign-owned under the Commission's foreign ownership analysis because the voting interests of its U.S. owners are held through a Cayman Islands entity. Terrier Media has filed a petition for declaratory ruling to permit Terrier Media and AGM to be up to 100% foreign owned. Such a determination would give Terrier Media additional flexibility going forward to consider efficient structures for any new investments it makes in broadcast properties. Grant of the petition will provide Terrier Media with certainty as it considers the opportunities presented by future transactions.

#### C. Divestitures to Comply with Local Radio Ownership Rule

As demonstrated in Section VII below, the Transaction complies with the Commission's local radio ownership rule in all respects, except that Cox Radio holds grandfathered combinations in two markets that Terrier Media may not acquire intact because they exceed the limits in the Commission's local radio ownership rule. To comply, Cox Radio will divest one FM radio station in each of two Nielsen Audio markets: Orlando, Florida, and Tampa-St. Petersburg-Clearwater, Florida.

The parties are concurrently filing applications with the Commission (the "Divestiture Trust Applications") to assign to a divestiture trust an FM station in the Orlando, Florida Nielsen Audio market (WPYO(FM), Maitland, FL) and an FM station in the Tampa-St. Petersburg-Clearwater, Florida Nielsen Audio market (WSUN(FM), Holiday, FL) (the "Divestiture Stations"). The Commission has permitted divestiture trust arrangements when a transaction involving multiple stations in multiple markets otherwise would cause a party to exceed the ownership caps in one or more markets. Under this well-established Commission

precedent, a beneficiary's ownership interest is not attributable to the beneficiary if it is properly insulated to prevent the exercise of control or influence over the trustee.

The relationship between Terrier Media, the trustee and the divestiture trust will be governed by (1) an Engagement Agreement dated as of June 28, 2019 between Terrier Media and the trustee, CXR Radio, LLC, a single-member limited liability company the sole member of which is Elliot B. Evers (the "Trustee"), and (2) a Trust Agreement between Cox Radio, Inc. and the Trustee (the "Trust Agreement") to be entered into immediately upon consummation of the proposed transfer of control that will establish the CXR Radio Station Trust (the "Divestiture Trust"). Those agreements provide, among other things, that the assets of the Divestiture Stations will be assigned to the Divestiture Trust, and that the Trustee shall have the power to effect sales of those stations to third parties as soon as reasonably practicable and at the maximum price reasonably attainable, provided that Cox Radio, Inc., as the proposed beneficiary, may establish a minimum acceptable price for the stations. If Cox Radio enters into an agreement to sell either or both Divestiture Stations prior to closing of the assignment of the Divestiture Stations to the Divestiture Trust, the Trustee shall assume the obligations of Cox Radio under such agreement pending consent of the Commission and any other required governmental approvals. The Trust Agreement will further provide that the Trustee shall have complete control over the stations placed in the Divestiture Trust and shall operate them as separate, independent and active market competitors.

In addition, under the terms of the proposed Trust Agreement:

- Terrier Media cannot replace the Trustee at will;
- Terrier Media cannot revoke the Divestiture Trust;
- The Trustee does not have a business, personal or extra-trust relationship with Terrier Media, its affiliates or any of the shareholders, directors, officers or employees of Terrier Media or its affiliates (each, a "Related Party");<sup>7</sup> and
- Neither Terrier Media nor any Related Party may communicate with the Trustee concerning the management and operation of the stations assigned to the Divestiture Trust, except to deliver financial reports or to facilitate the sale of the stations to an unaffiliated third party, and then any permitted communication must be evidenced in writing and retained by the Divestiture Trust for inspection upon Commission request.

Accordingly, the proposed Divestiture Trust conforms to the Commission's attribution insulation standards. It also conforms, in all respects material to the Commission's regulatory concerns, to prior trust agreements that the Commission has recently approved, including the divestiture trust reviewed and approved by the Commission in connection with iHeartMedia's recent emergence from bankruptcy.<sup>8</sup> Because the Divestiture Trust structure includes proper insulation, the Divestiture Stations assigned to the Divestiture Trust will not be attributable to Cox Radio or Terrier Media for the purposes of the local radio ownership rule upon consummation of the assignment of the Divestiture Stations to the Divestiture Trust, thereby permitting the proposed transfer of control of Cox Radio to Terrier Media to proceed in compliance with the Commission's local radio ownership rule.

#### D. Renewals of Radio Broadcast Stations Subject to Purchase Agreement

One or more of the radio broadcast stations that Terrier Media proposes to acquire pursuant to the Purchase Agreement may have a renewal application pending before the Commission during the time that the instant transfer application is pending. Consistent with the Commission's policy permitting consummation of a multi-station transfer of control overlapping with a renewal cycle, Terrier Media, as transferee, hereby assents to succeeding to the place of the current licensees for any pending renewal applications for those radio broadcast stations over which Terrier Media will acquire control as a result of the Transaction.<sup>9</sup>

### III. Public Interest Benefits of the Transaction

Terrier Media's proposed purchase of Cox Radio will serve the public interest. PMC Equity, a newly created limited partnership, will provide equity capital for the transaction. As opposed to the short-term, quarter-to-quarter focus of the public markets, PMC Equity has been structured to accommodate long-term investors favoring enterprises with a buy and build strategy that invests in businesses in collaboration with strong management teams.

As the proposed owner of the Cox Radio Stations, Terrier Media will benefit from financial, strategic, and management expertise provided by advisory affiliates of AGM, a publicly traded U.S. company with more than 1000 employees that, as of December 31, 2018, has under its management \$280 billion in assets, including private equity assets of more than \$69 billion dollars.<sup>10</sup> AGM affiliated funds in the private equity space focus on the long term buy

and build strategy and strong management teams that underlie the approach that Terrier Media and VoteCo are taking with this Transaction.

AGM and its affiliates have been involved in private equity transactions involving more than 150 companies across a wide range of business sectors. Principals of AGM and its subsidiaries are involved in the management of various funds and their related entities, including the most recent AGM affiliated fund, Apollo Investment Fund IX, L.P., which itself has more than \$24.7 billion dollars in committed capital. Accordingly, AGM affiliates have contributed to the development and organization of the proposed transaction, including assessment of financial requirements, arrangements for equity and debt capital, and development of the transaction structure.

AGM and its affiliates, however, are not broadcast operators. Neither AGM nor any AGM-affiliated fund will hold any limited partnership interest in PMC Equity or any stock interest in Terrier Holdings or in any Terrier Holdings subsidiary. The principal activities of AGM affiliates with respect to this Transaction will be governed by two consulting arrangements, which will involve non-exclusive strategic advice, including with respect to any future follow-on transactions in the broadcasting space. Except as provided in those arrangements, neither AGM nor its affiliates will be involved in the day-to-day operations of the Cox Radio Stations.

Funds affiliated with AGM will direct their limited partners to directly commit capital to PMC Equity in exchange for limited partnership interests in that entity, the proceeds of which will be used to fund the acquisition of the Cox Radio Stations. The terms of the limited partnership interests (and, in turn, their indirect investment in Terrier Media) will be governed solely and exclusively by the PMC Equity limited partnership agreement. That limited partnership agreement will insulate each such investor from material involvement in the business of PMC Equity and from its indirect investment in Terrier Media, and each investor will have only those few restricted rights and investor protections that the Commission permits for insulated limited partners. No manager of any AGM-affiliated fund will have authority to manage or otherwise make decisions with respect to VoteCo or Terrier Media's management or decision-making. No manager or employee of AGM or of any AGM affiliate will hold any limited partnership interests in PMC Equity.

At or after the closing, Terrier Holdings or one of its wholly owned subsidiaries (collectively, "Terrier"), as is typical for private equity transactions, will enter into two consulting agreements with affiliates of AGM, one to provide strategic advice to senior management about financing transactions and other material transactions, and the other to provide advice specifically with respect to future acquisitions. In neither case will the fee be based on Terrier's financial performance. The agreements will not require Terrier to follow any advice given or undertake any transaction, and they will not preclude Terrier from retaining other advisors or penalize Terrier for doing so. No other agreements between Terrier entities and AGM affiliates or AGM are contemplated.

VoteCo managing members John Suydam and Scott Kleinman are officers of AGM and each of the managing members and officers of VoteCo is employed by an affiliate of AGM, as

are certain officers of Terrier Media. None of these individuals, however, is a party to any agreement with AGM or any AGM affiliate with respect to those roles for VoteCo and Terrier Media and each will act in his or her individual capacity in those roles. With respect to VoteCo officers, any officers appointed by the managing members may be removed by those members at any time with or without cause. With respect to Terrier Media officers, any officer elected or appointed by the Board of Directors of Terrier Media may be removed at any time by the affirmative vote of a majority of the Board of Directors. Neither AGM nor any AGM affiliate will have any voting rights or attributable interest in VoteCo, Titan, PMC Equity, Terrier Holdings or any subsidiary of Terrier Holdings.

## A. Terrier Media's Operation of the Cox Radio Stations will Enhance the Public Interest

Terrier Media's principals have a long track record of superior results in strengthening businesses and making them more competitive. They also will have access to Apollo and its experience in numerous other successful investments. That collective experience will allow Terrier Media to develop and present creative approaches to address the increasing challenges faced by the television broadcast industry from an unprecedented number of new, well-funded competitors. At the same time, Terrier Media will benefit from the businesses' existing leadership and management. Cox Parent will maintain meaningful ownership interests in the new broadcast company and will make meaningful contributions to its strategic direction. Terrier Media also intends to maintain Cox's existing management and operations with corporate headquarters for the new company located in Atlanta, Georgia.<sup>11</sup>

Of the 50 stations in the Transaction, 31 are ranked in the top 10 in their markets with approximately half of the stations ranked in the top five. The strength of the brands is exemplified in Atlanta with WSB(AM) news talk radio serving Atlanta listeners for nearly 100 years; Miami's Hot 105FM, the epicenter of South Florida's urban community; and Houston Today's Country, an award-winning country music favorite. Fueled by exceptional on-air and programming talent, in-depth research and powerful marketing, Cox Radio maximizes its reach throughout its markets, as powerfully demonstrated in San Antonio where it delivers five of the top six stations. Cox Radio's bond with its communities extends beyond the bounds of the signals transmitted to over 100 well-established community-centric events, disaster preparedness and recovery, and local charity support.

Terrier Media is fully committed to continuing the Cox Radio Stations' long history of excellent local news and entertainment programming. Terrier Media expects to support those efforts with key investments that will enable the stations to better serve the public. Terrier Media will continue the stations' focus on the journalistic integrity, news quality, and commitment to community that Cox has demonstrated in its ownership of the stations. Terrier Media is investing in the broadcasting market, because it believes local broadcast stations serve as a critical outlet for advertisers and a source of local news and information for listeners.

Terrier Media also believes it is critical to continue to engage the local communities through active social engagement.

Terrier Media intends to expand Cox's outstanding efforts to produce and acquire highquality programming for its stations and the local communities they serve. Terrier Media plans to invest in the creation of local content, including local news. Specifically, Terrier Media intends to undertake, among others, the following efforts:

- improving the stations' physical plant, including studio, back office and transmission equipment;
- capitalizing on the quality news reporting from Cox's Washington News Bureau, which will be available to the combined group of stations after the closing. Cox's Washington News Bureau has a fully-staffed team that covers stories of national interest as well as matters out of Washington that are of particular interest to individual station markets; <sup>12</sup> and
- growing each station's digital presence in its local market through improvements in station websites and applications.

In addition, Terrier Media has on file with the FCC applications to acquire television and other radio stations in Dayton from Cox. By continuing to operate all the Cox television and radio stations together, in addition to those in Dayton, Terrier Media will be able to utilize efficiencies of coordinated operations to increase investment and ensure that local news and information needs are well served across all of its markets. Moreover, Terrier Media has sought Commission consent to the acquisition of television stations from Northwest Broadcasting. Terrier Media will leverage the expanded reach of the combined television and radio station group for a broader distribution of programming addressing issues of regional and national importance. Indeed, the Commission has acknowledged that co-ownership of broadcast radio and television stations yields public interest benefits such as improved outreach to the local community and increased news and public affairs programming.<sup>13</sup>

The parties have excluded from the application the exhibits and schedules to the Purchase Agreement. The excluded documents contain proprietary information, duplicate information already included in the application or in the possession of the Commission, or are not germane to the Commission's consideration of this application.<sup>15</sup> Copies of the excluded documents will be provided to the Commission upon request, subject to the right of the parties to ask that the material submitted be held in confidence and not be made available pursuant to applicable rules and policies of the Commission that restrict public access to confidential and proprietary information.

#### VII. Local Radio Ownership Compliance

Under Section 73.3555(a)(1) of the Commission's rules, the FCC uses a tiered approach, as described below, to determine whether a combination of commonly-owned radio stations comply with the local radio ownership limits for any particular market.<sup>16</sup>

To determine the number of stations in a market, the Commission relies on one of three methodologies:

**1.** <u>Nielsen Market Methodology</u>: When more than one commonly owned radio station is licensed to a community within a Nielsen Audio market, the FCC counts the number of commercial and noncommercial radio stations that are either "home" to the Metro market or are licensed to a community within geographic boundaries of that market (the "Nielsen Market Methodology").<sup>17</sup>

2. <u>Contour Methodology</u>: For combinations that are licensed to communities that are not home to any Nielsen Audio market, the Commission defines the market as the area where the principal community contours of the commonly-owned stations overlap. To determine the number of stations in that market, the Commission counts all stations whose principal community contours overlap that of at least one of the commonly-owned stations. The Commission, however, excludes all stations whose transmitters are greater than 92 kilometers from the mutual overlap area and any commonly owned stations that are not included already in the market (the "Contour Methodology").<sup>18</sup>

**3.** <u>Nielsen-Contour Hybrid Methodology</u>: The FCC requires an analysis under both the Nielsen Market Methodology and the Contour Methodology in two situations: (i) if at least one of the commonly-owned stations is "home" to a Nielsen Audio market but it is licensed to a community outside that market or (ii) if a station is licensed to a community within a Nielsen Audio market but its principal community contour overlaps that of another commonly-owned station that is not licensed to a community within any Nielsen Audio market (the "Nielsen-Contour Hybrid Methodology").<sup>19</sup>

The Transaction will not create any new radio combinations. Terrier Media can acquire the Cox Radio Stations in all markets, except in the Orlando and Tampa markets. Divestiture of one FM station in each of those markets is required because Cox Radio currently owns a grandfathered cluster. Below is a market-by-market analysis of the broadcast interests that will be held by Terrier Media and the parties to the applications. The markets are broken down as follows: (i) Rule Compliant Markets and (ii) Divestiture Markets.

## A. Rule Compliant Markets

In each of the following markets, the Transaction complies with the Commission's local radio ownership rules without the need for any waiver or divestitures.<sup>20</sup>

## Athens, Georgia

The Commission requires the submission of a contour overlap analysis to demonstrate compliance with the local radio ownership rule for stations that are licensed to communities outside of a Nielsen Audio market. As described in the attached contour-based analysis prepared by W. Jeffrey Reynolds of du Treil, Lundin & Rackley, Inc., the Transaction complies with the Commission's rules. In each of the defined radio markets created using the contour overlap analysis, there are no less than 70 radio stations. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 6 commercial radio stations in the Athens, GA market (2 AM stations and 4 FM stations), which is permitted under the local radio ownership rule.

## Atlanta, Georgia

As shown in the attached BIA FCC Geographic Market Definition report for Atlanta, GA, there are 85 commercial and noncommercial radio stations that are home to the Atlanta, GA Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 5 commercial radio stations (1 AM station and 4 FM stations), which is permitted under the local radio ownership rule.

# Houston, Texas

As shown in the attached BIA FCC Geographic Market Definition report for Houston, TX, there are 78 commercial and noncommercial radio stations that are home to the Houston, TX Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 4 commercial FM radio stations, which is permitted under the local radio ownership rule.

# Jacksonville, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Jacksonville, FL, there are 45 commercial and noncommercial radio stations that are home to the Jacksonville, FL Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction,

Terrier Media will have an attributable interest in 6 commercial radio stations (1 AM station and 5 FM stations), which is permitted under the local radio ownership rule.

#### <u>Miami, Florida</u>

As shown in the attached BIA FCC Geographic Market Definition report for Miami, FL, there are 61 commercial and noncommercial radio stations that are home to the Miami, FL Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 4 commercial FM radio stations, which is permitted under the local radio ownership rule.

#### Nassau-Suffolk, New York

As shown in the attached BIA FCC Geographic Market Definition report for Nassau-Suffolk, NY, there are 46 commercial and noncommercial radio stations that are home to the Nassau-Suffolk, NY Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 3 commercial FM radio stations, which is permitted under the local radio ownership rule.

#### San Antonio, Texas

As shown in the attached BIA FCC Geographic Market Definition report for San Antonio, TX, there are 60 commercial and noncommercial radio stations that are home to the San Antonio, TX Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 7 commercial radio stations (2 AM stations and 5 FM stations), which is permitted under the local radio ownership rule.

The community of license for one of the stations – KONO(AM), Helotes, TX – listed as "home" to the San Antonio, TX Nielsen Audio market, is located outside of the market. The Commission requires the submission of a contour overlap analysis to demonstrate compliance with the local radio ownership rule for stations that are licensed to communities outside of a Nielsen Audio market. As described by the contour-based analysis prepared by W. Jeffrey Reynolds of du Treil, Lundin & Rackley, Inc. the Transaction complies with the Commission's rules.

#### Tulsa, Oklahoma

As shown in the attached BIA FCC Geographic Market Definition report for Tulsa, OK, there are 41 commercial and noncommercial radio stations that are home to the San Antonio, TX Nielsen Audio market. Therefore, common ownership of seven radio stations, no more than four in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 5 commercial radio stations (1 AM station and 4 FM stations), which is permitted under the local radio ownership rule.

#### **B.** Divestiture Markets

To comply with the local radio ownership rule, divestitures will be required in the Orlando, FL and Tampa, FL markets (the "Required Divestitures"). Terrier Media will either make the Required Divestitures prior to closing or assign these stations to the Divestiture Trust simultaneously with the closing of the Transaction, as described in Section II.

#### Orlando, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Orlando, FL, there are 40 commercial and noncommercial radio stations that are home to the Orlando, FL Nielsen Audio market. Therefore, common ownership of seven radio stations, no more than four in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 5 commercial radio stations (1 AM station and 4 FM stations), which is permitted under the local radio ownership rule. WPYO(FM), Maitland, FL will be divested to a third party at the closing of the Transaction or the station will be assigned to the Divestiture Trust.

#### Tampa, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Tampa, FL, there are 48 commercial and noncommercial radio stations that are home to the Tampa, FL Nielsen Audio market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Transaction, Terrier Media will have an attributable interest in 5 commercial FM radio stations, which is permitted under the local radio ownership rule. WSUN(FM), Holiday, FL will be divested to a third party at the closing of the Transaction or the station will be assigned to the Divestiture Trust.

#### VIII. Pending Applications and Cut-Off Rules

The Applicants separately will file applications in the appropriate bureaus requesting Commission consent for the transfer of control of certain earth station, microwave, and land mobile facilities held by Cox Radio. It is intended that the applications filed in connection with the Purchase Agreement include all of the licenses and other authorizations held by Cox Radio. Cox Radio may now have on file, and may hereafter file, additional requests for authorizations for new or modified facilities that may be granted before the Commission takes action on the above-described transfer of control applications. Accordingly, the Applicants request that the Commission approval of the applications filed in connection with the Transaction include (1) any authorization issued to Cox Radio (except for those licenses and authorizations associated with Cox Radio's stations in the Dayton Nielsen Audio market) while the instant applications are pending before the Commission and during the period required for consummation of the Transaction, and (2) any applications filed by Cox Radio that are pending at the time of consummation. Inclusion of authorizations issued while the Transaction is pending and during the consummation period, and applications pending at the time of consummation, are both consistent with prior Commission decisions.<sup>21</sup>

Additionally, pursuant to Sections 1.927(h), 1.929(a)(2), and 1.933(b) of the Commission's Rules, to the extent necessary, Terrier Media requests a blanket exemption from any applicable cut-off rules in cases where Terrier Media files amendments to pending applications in order to reflect consummation of the proposed Transaction so that such amendments are not treated as disqualifying amendments. The nature of the proposed Transaction demonstrates that the ownership changes would not be made for the purpose of acquiring any particular pending application, but as part of a larger transaction undertaken for an independent and legitimate business purpose. Grant of this request would be consistent with prior Commission decisions that routinely have granted a blanket exemption in cases involving multiple-license transactions.<sup>22</sup>





In this case, since WSRV/FM is common to all markets, its principal community contour was employed for the analysis.

Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area are to be employed in the count of stations. In this case, only stations that are located within 92 km of all three of the mutual overlap areas for each of the three markets were employed. Commonly owned CMG stations were not considered in the count of stations in the defined market. The results of the analysis are tabulated below:



## RADIO MULTIPLE OWNERSHIP ANALYSIS SAN ANTONIO, TEXAS

#### Stations Considered

The following CMG stations are considered to be in the San Antonio, TX market for analysis:

- 1. KKYX(AM)
- 2. KCYY(FM)
- 3. KTKX(FM)
- 4. KONO(AM)

- 7. KSMG(FM)

The principal community contours of all of these stations are depicted on a map included herewith as Figure 1. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations). An ownership study was prepared in accordance with the FCC multiple ownership rules as outlined in Section 73.3555 under the interim contour analysis procedure.

#### San Antonio Radio Market

The radio market applicable to common ownership of the subject San Antonio market stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. As listed in the table below, there is one defined radio markets formed by the subject stations in the San Antonio market:

#### Count of Stations in Defined Markets

The number of radio stations in a defined radio market is determined by counting the operating stations that have principal community contours that intersect the principal community contours that define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area are to be employed in the count of stations. Commonly owned CMG stations were not considered in the count of stations in the defined market. The results of the analysis are tabulated below:


