Tier One Networks (“Tier One”), by its attorneys, hereby notifies the Federal Communications Commission (“Commission”) that Tier One is surrendering its international Section 214 authorization effective immediately. Tier One was granted international Section 214 authority in file number ITC-214-20041222-00489 (granted January 13, 2005).

Tier One currently does not provide, and has never provided, international telecommunications services and has no customers for international telecommunications service. Consequently, Tier One has had no international telecommunications service customers within the past thirty days. Therefore, there are and were no customers to be notified in accordance with Section 63.19(a)(1) of the Commission’s Rules, and no customer notification is attached to this letter.


